## INDUSTRY OVERVIEW

The Oil & Gas Regulatory Authority (OGRA) plays a significant role in the country's economy, with the majority of Pakistan's energy needs being met through oil and gas imports. Pakistan has proven reserves of natural gas, coal, and small amounts of oil. The government of Pakistan has been making efforts to increase domestic production and exploration to reduce dependence on imports.

OGRA plays a key role in regulating and monitoring the oil and gas sector in Pakistan. OGRA issues licenses, sets prices, and ensures compliance with regulations. The Authority also monitors the performance of the sector, and takes steps to protect the interests of consumers.

Pakistan's Oil & Gas Development Company Limited (OGDCL) and Pakistan Petroleum Limited (PPL) are the two major state-owned oil and gas exploration and production companies in the country. Pakistan State Oil (PSO) is the largest oil marketing company in Pakistan.

According to the Pakistan Bureau of Statistics, in 2020, Pakistan imported \$13.5 billion worth of crude oil and petroleum products, which accounted for about 25% of the total import bill. Whereas, the BP Statistical Review of World Energy 2020 says that Pakistan's total primary energy consumption was around 34.5 Mtoe, of which oil and natural gas accounted for about 57%. Pakistan's natural gas production was around 4.5 billion cubic feet per day (bcf/d) in 2020.
